ORDER:

In the Government Order first read above, amendments were issued to the Special Rules for the Tamil Nadu Ministerial Service for filling up of 25% of substantive vacancies in the post of Assistant by direct recruitment through Tamil Nadu Public Service Commission in the Rural Development and Panchayat Raj Department.

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has sent a proposal for further amendments.

3. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to Special Rules for the Tamil Nadu Ministerial Service (Section 22 in volume III of the Tamil Nadu Services Manual 1970)

2. The amendments hereby made shall be deemed to have come into force on the 29th October 2014.

AMENDMENTS.

In the said Special Rules, in Annexure -IX-X,-

(1) for rule 3, the following rule shall be substituted, namely:-

“3(i) The Director of Rural Development and Panchayat Raj shall be the appointing authority in respect of Office of the Director of Rural Development and Panchayat Raj, Chennai;

(ii) The Collectors of the respective Districts shall be the appointing authority in respect of Development Branches in the Collectorates, Offices of the Assistant Director (Panchayats), Assistant Director(Audit), Panchayat Union Offices taken together in each Revenue District and Regional Institute of Rural Developments in the Districts”;

(2) In rule 8, in clause (b), the following proviso shall be added, namely:-

“Provided that the directly recruited Assistants who have been recruited prior to 29th October 2014 shall be exempted from passing of the tests mentioned in item (i) and (iii) for the purpose of declaration of probation”.
